




- The "Lost" History: Has been definitely located in the SAF Office; has been promised to us and is
  undergoing final, pre-release reviews under Dick Scofield's watchful eye... POS considering hiring a
  professional writer to assess feasibility of producing a useful, worthwhile document of historic
  value...
- Carve Out/Streamlined Management Benefits/"Lessons Learned" Study: Intended to determine if
  any of the COSM methods we used could save today's development programs time, money,
  headcount...
  - Status: Polling of POS membership for actual past examples of Senior High COSM advantages that might apply today has been put on hold pending further discussion by the membership...
- AK Effort & Vehicle: POS has been advised it might be possible to declassify enough of AK's effort and vehicle to permit a display at the USAF Museum at W-P AFB within the next two years...
- Film -to-Video Project: Classified films from various Senior High programs, including early tests, has been located and is being reviewed for the POS by a SAF-level consultant for possible declassification and release...



#### Note from Dr Collins

I'd like to throw out an idea. I've discussed portions of this with some of you in the past, but would like to more formally request your help. I'm teaching the annual RCS capstone course again this quarter. This is a combination of lecture and laboratory time designed to tie together all the theoretical material the LO students have been studying for the past 3 quarters. As such, I like to bring in some of the more "practical" considerations in RCS analysis, measurement, and reduction. The course is strictly US military and taught at up to a SECRET collateral classification. I would like to bring in a bit more of the history to provide some context for the students. I thought of the last short course and museum tour. While I do have some of the videos from that time, they are not the best quality and have some missing interviews. So here's the idea/request

I would like to recreate the tour for the students (there are 7 students - several who are coming to RYS). My proposal would be to meet at the museum and spend 1-2 hours visiting the various aircraft of interest. I'd like each of you to talk a little about the subject aircraft from an historical perspective at an unclassified level. I will record the videos as before and have you all review them before creating an FOUO DVD for future classes. My goal will be to make this as painless (i.e. little time investment) on your part as possible. The formal lecture times for the class follow, but we can work around your mutual schedules. Also if there is someone else you feel would be a good candidate to participate, please pass on my invitation.

Thank you for considering this opportunity to influence the next LO engineers!

The normal offering for this course is Jun-Sep each year. It would be wonderful if you could participate or perhaps recommend others. All of these officer students go directly into the community and would benefit greatly from your experience. Please feel free to contact me with questions or ideas.

#### Charter November 2007 (1 of 4)

"Purpose. The purpose of the Pioneers of Stealth organization is to
perpetuate the spirit and achievements of a relatively small number of
government and industry people in the early days of low observables
technology and development......Maintaining this social relationship is
extremely important and a primary objective of this organization."



# Pioneers of Stealth



#### Charter November 2007 (2 of 4)

**Membership:** Membership in the Pioneers of Stealth organization is limited to all government and industry employees who were involved in the planning and execution of the low observable programs managed under the then Aeronautical Systems Division's Special Projects Office (subsequently ASD/XRJ) *prior to December 17, 1993,* the date of the first operational B-2 bomber to Whiteman AFB, MO, on the 90<sup>th</sup> anniversary of the Wright Brothers first flight.

- Dues. (Current) Membership dues will be \$25.00 per year. Individuals desiring to continue as members (or those desiring to become new members) must provide an indication of their association with the ASD low observable programs prior to December 17, 1993, a current mailing and e-mail address, a phone number and a check for \$25.00 to the Pioneers of Stealth Treasurer.
- (Proposed) New Members. Individuals desiring to become new members must provide an indication of their association with the ASD low observable programs prior to December 17, 1993; a current mailing and e-mail address and phone number; and an initiation fee of \$50.00





#### Charter November 2007 (3 of 4)

- Officers. (Current) The officers will be President, Vice President, Secretary and Treasurer. Officers will elected by the membership at each reunion.
- Officers. (Proposed) The officers will be President, Vice President, Secretary and Treasurer. Officers will elected by the membership prior to every other reunion or not more than every four years.
- Senior Advisory Group (SAG). (Current) The SAG will be made up of 3 to 4
  members (a mix of government and industry) who are designated as Principal
  Pioneers by the membership and the current President of the POS.....
- Senior Advisory Group (SAG). (Proposed) The SAG will be made up of members (a mix of government and industry) who are designated as Principal Pioneers by the membership and the current President of the POS. The past President and Vice President will automatically become members of the SAG upon completion of their term.....
